This public dashboard provides summary information derived from CMS Inpatient Prospective Payment System (IPPS) Final Rules for FY 2021-2025 and aggregated statistics from Medicare inpatient limited data set standard analytic files. This includes:

- Average cost per inpatient stay by MS-DRG and cost-center, and national Medicare fee-for-service payment rate by MS-DRG assuming the hospital submits quality data and is a meaningful EHR user
- Total IPPS cases and payments from 2019-2024 Q3
- Most common primary diagnosis and procedure codes for each MS-DRG


