McDermott Adds In-House Health Care Pro In DC

After earning her law degree from University of Michigan Law School, Kelly started her career as an associate in Swidler Berlin LLP's corporate group in 2001. She stayed with the firm when it merged with Bingham McCutchen in 2006, then moved in-house in June 2010 as an attorney with Coventry Health Care.

In June 2013, Kelly moved to CVS Health as counsel on the company's Aetna Medicare subsidiary. She joined Signify Health in July 2021 as chief compliance officer and senior vice president and left the company this month as deputy general counsel and chief compliance officer.
